### Typical Number of Pulse Repetition:

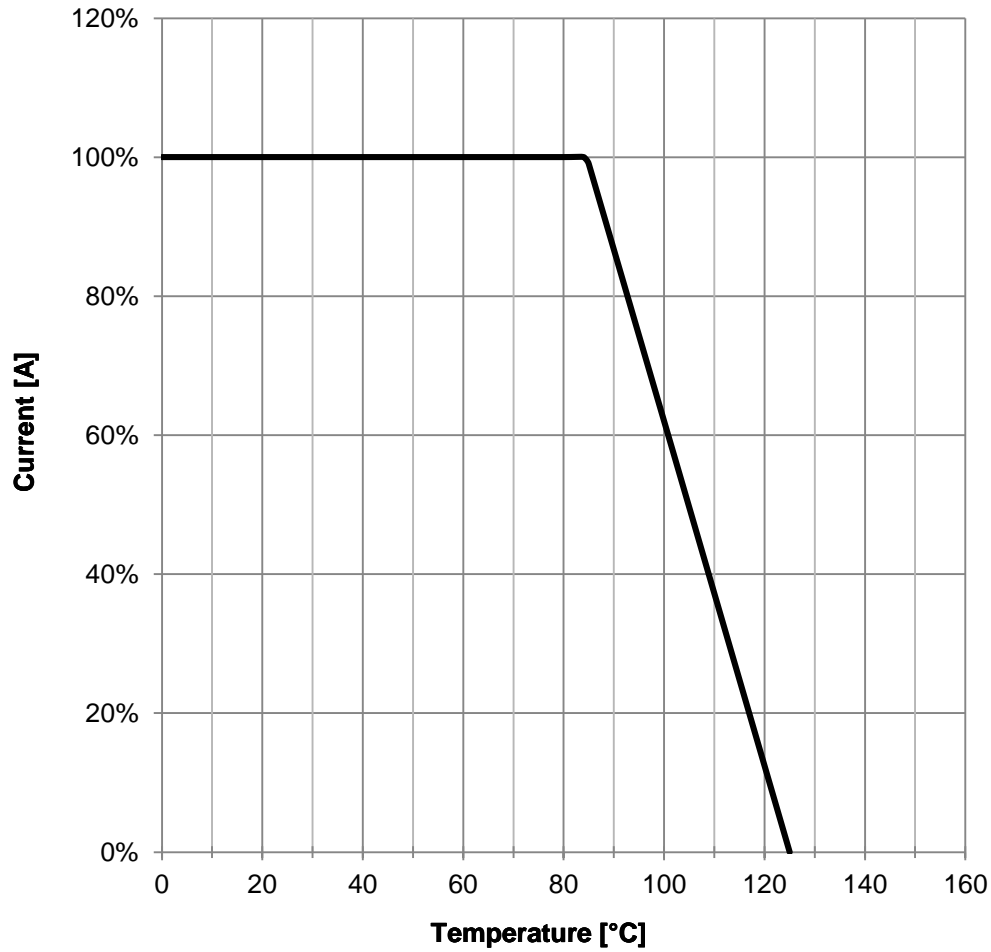
